It sponsors Wildlife Education day events at Park HQ with about 450 attendees and escorts children's groups to wetlands for over 950 children. It leads about 100 field trips to local habitats, holds monthly lecture meetings, operates a nature shop for its members and makes classroom presentations to about 1,000 children. c - Conservation and Environmental Action - The Society contributes volunteer services and support to a variety of environmental activities including a bluebird recovery and nest box program, burrowing owl protection, and citizen science projects such as environmental home gardening.
